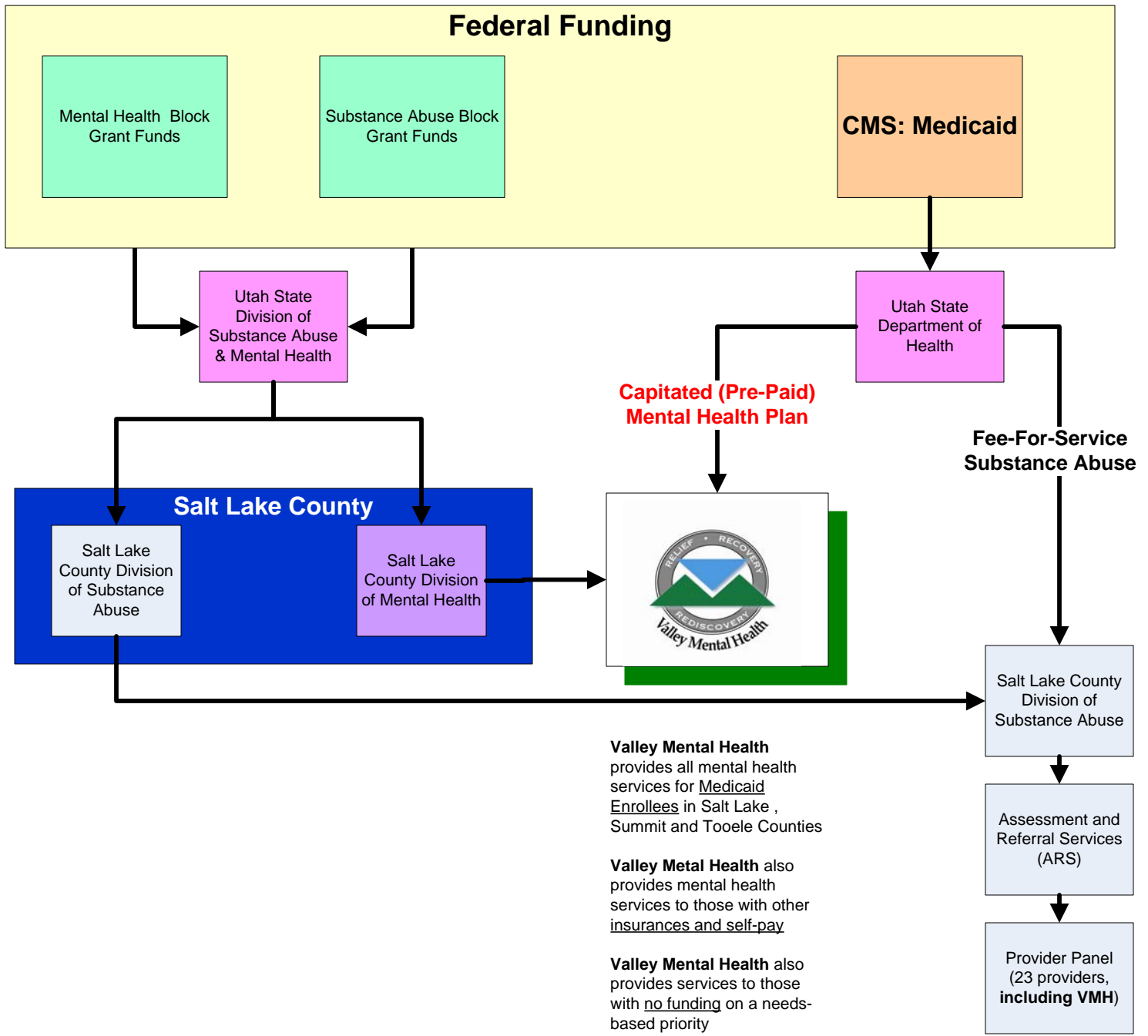


# Public Funding of Behavioral Healthcare Services in Salt Lake County
